The core concepts include management, customer, requirements, policy, procedure, planning, performance, objective, control, monitoring, measurement, auditing, decision-making, corrective-action & nonconformity. The **IATF 16949:2016** is a technical standard for Quality Management Systems in the Automotive Sector and is released and controlled by "**International Automotive Task Force (IATF)**" based in Geneva, Switzerland.

## **CERTIFICATION OF IATF 16949:2016**

IATF 16949:2016 certification is a mandatory Sector Specific Automotive industry requirement that aligns Automotive Quality Management Systems throughout the world.

IATF 16949:2016 certification is a seal of approval from an "**International Automotive Task force (IATF)**" accredited third party body

that an Organization / Company / Firm or an entity which is designing and/or manufacturing or catering their relevant services parts to Automotive Supply Chain, operating as per Sector Specific international standards developed and published by the "**International Automotive Task force (IATF)**".

Automotive Vehicle Assembly Plants which are **Original Equipments Manufacturers (OEMs)** are excluded from this requirements.

While for Suppliers of OEMs (Tier-1) and their all Sub Suppliers (Tier-2) and next level Sub Suppliers (Tier-3) etc. in Automotive Supply Chain, the Compliance and Registration for IATF 16949:2016 is mandatory.

## TYPES OF CERTIFICATION OF IATF 16949:2016

There are two types of certification:

1. Letter of Conformance (LOC)
2. Certificate of Registration

LOC is the proof of Assessment by a competent Auditor in an organization which has implemented their Quality Management System as per guidelines of IATF 16949:2016 Standard, but since the organization had not supplied its' manufactured products and/or relevant services parts to any of Automotive Supply Chain in last one year, thus as per "Rules for achieving and maintaining IATF Recognition-IATF Rules 5th Edition (Released in Nov. 2016 ) and its' further "Sanctioned Interpretations" (Released by IATF), the organization is not eligible to get Registration & Recognition with IATF 16949.

While The "Certificate of Registration" is the proof of Recognition and Registration by IATF for an organization which is in a Single or multiple regular Automotive Supply Chains, based on Assessment done by an IATF Accredited Certification body and IATF approve ADP Qualified Automotive Auditors.
