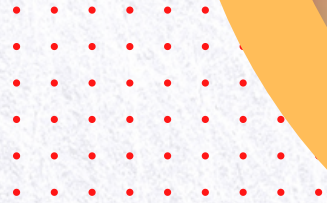

BRIEF ABOUT CATEGORIES OF

APAX BOOK OF WORLD RECORDS (ABWR)

Setting a New World Record or Breaking an Existing World Record

This category is for listing and registration of such applicants or Organizations, who has either set a new world record, which is not registered with any other recognized Book of World Records/ agency, or if applicant or organization has break the existing records, which is already registered with any other recognized Book of World Records/ agency, Eg. – Max. Pushup in a minute by an applicant, Conduction of a longest baton relay race in a day etc.

Innovation

This category is for listing and registration of such applicants or Organizations, who has made an unique innovation machine/ device/ practice/ mechanism/ system etc., which is not registered with any other recognized Book of World Records/ agency, Eg. – Development a unique mobile application for hiring of Bicycle, Designing and development of a unique machine to reduce the human effort etc.

Mass Event

This category is for listing and registration of such applicants or Organizations, who has conducted a mass event which includes the presence of mob of participants/ people and which is not registered with any other recognized Book of World Records/ agency. Eg. – Conduction of a Folk Song camp with 5000 Nos. of Singers at a single venue etc.

Success Stories

This category is for listing and registration of such applicants or Organizations, who has made a Success story and may be helpful to motivate Society and which is not registered with any other recognized Book of World Records/ agency. Eg. – Achievement of Turnover of 200 Crores in an year after Startup, Becoming an IAS Officer without getting support and help from any institute by person belongs to a surviving family etc.

Literature

This category is for listing and registration of such applicants or Organizations, who has wrote a literature in any language and in any genre and which is not registered with any other recognized Book of World Records/ agency. Eg. – a Novel, a Poetry etc.

Charity

This category is for listing and registration of such applicants or Organizations, who has done a charity for welfare of society and which is not registered with any other recognized Book of World Records/ agency. Eg. – a Charity to Orphanage etc.

Social Work

This category is for listing and registration of such applicants or Organizations, who has conducted a Social Work for welfare of society and which is not registered with any other recognized Book of World Records/ agency. Eg. – Conduction of Free Health Checkup Camp, Distribution of Cloths to Poor, Establishment of Old-Age home etc.

PROTOCOL FOR SUBMISSION OF ENTRIES

APAX BOOK OF WORLD RECORDS (ABWR)

- Standard National and International norms and rules should be adhered to while setting national and world records. In some cases there may be additional event-specific norms that need to be observed.
- The onus of proving a record claim rests on the Applicant. The claim, signed by the Applicant, should be backed by adequate and satisfactory documents without which it will not be accepted. Materials submitted as supporting evidence, like press clippings, audio/ videotapes, flash/pen drives, CDs and photographs, become the property of the publisher APAX Assessment Private Limited, but only copies should be submitted with the originals kept safe by the claimant for Life after the claim has been accepted. Forms such as the Application Form duly signed by the Applicant and validating/ witnessing authorities as indicated by the Adjudicator of ABWR and/ or the rules and guidelines need to be submitted in the original (hard copy) and a copy retained by the applicant/applicants for Life after the claim has been accepted. ABWR does not take any responsibility for lost material/s if the record is questioned or objected to by any person. In case of a query or objection raised, the responsibility of providing the evidence again for re-verification and all expenditures therein lies with the Applicant.
- Authentication of Conduction of Claim Records should be done by Adjudicator of ABWR or by someone who is competent and in a responsible position, such as a Gazetted Officer, District Magistrate or Principal of a school/college, Officer Rank Police Officers unless specified otherwise.
- Update yourself with the latest record before any Attempt to break it. Potential record-breakers should inform ABWR at least 30 days in advance about the record Attempt details and procedure in order to avoid disqualification on technicalities.
- While breaking an existing record, follow the rules, technical specifications and set precedents.
- Records should be absolute and not technical offshoots as well as those records which have the human life risk or potential threats for Environment and Biodiversity will not be entertain and will not be accepted by ABWR.
- While ABWR does accept new categories, these will have to be of high interest value and have definable and comparable parameters, and these are entirely subject to the ABWR Jury Members' decision. For example, even if no record exists, a two-hour marathon for guitar playing will not be accepted.
- ABWR Does not support the gender discrimination, thus not every record set by an individual gender "Transgender" is eligible for entry as the sub-category 'First Transgender to ...'
- Collections should have a basic 'standard'. Limited numbers of obscure articles may not be accepted unless of exceptional interest value, and that shall be decided upon by the ABWR Team.
- Before attempting any driving record, Applicants have to submit a copy of the following document/documents, as applicable, attested by a Gazetted Officer, Notary Public: their valid driving license/earlier experience certificate in case of motor sport or bicycling record; pilot's license/ aero sports course certificate/earlier experience certificate in case of aero sports record; mountaineering/ mountain sports course certificate/earlier experience certificate in case of a mountain sports record; and water sports course certificate/ earlier experience certificate in case of a water sports record to the ABWR office for prior approval.

PROTOCOL FOR SUBMISSION OF ENTRIES

APAX BOOK OF WORLD RECORDS (ABWR)

- The ABWR Team would like all claimants to send in supporting photographs and video clips. In physical evidence with documents or photographs, do not staple them to your entry. Use detachable clips. In cases where applicable and as indicated by the ABWR Team, time- and date-stamped video recordings of the Attempt must be provided.
- Any record in the book may be reconsidered or dropped without prior intimation.
- Certificates issued are valid only for the date or period specified and will be considered ended if surpassed by a new record, and/or change in criteria, measuring methods, or if disputed and found to be erroneous on re-verification.
- For reasons of space or any other reasons, a confirmed entry may be dropped at the time of going to press. The ABWR Team may inform the Applicant of the change in status but is not bound to do so.
- Indian Record holders are entitled to ONE complimentary copy of their certificate and its postage, if eligible, and further copies need to be ordered by writing to the ABWR Team and on payment (including GST) as indicated. Record holders outside India are entitled to ONE complimentary copy of their certificate but will need to pay courier and/or postal charges (including applicable taxes/surcharges). Requests for the reissue of older certificates issued in previous years are considered on a case by case basis and such certificates reissued on payment within reasonable time as per printing schedules provided the record is accessible in our archived editions.
- If new record holders do not receive their certificate by two months after the release of the book, please contact the ABWR office.
- The ABWR Jury Members reserves the sole right to decide on the suitability of all records for inclusion in the book. The Jury's decision on all such matters is final. Any attempt to browbeat or threaten the ABWR Team or representatives shall result in instant disqualification.
- ATTEMPTS BY MINORS: Records by minors below 14 years are not accepted, except under certain memory-related categories, select skill and art-based categories, and certain recognized national and international tournament categories as decided by the respective Consultants for specific sports.
- Records that are against the law or those that require excessive physical exertion detrimental to a minor's health will not be accepted by ABWR.

OBJECTIONS/DISCREPANCIES:

- Any typographical error or inaccuracy in the statement of a record or certificate should be pointed out by the record holder immediately.
- Objections raised by any person regarding any published entry shall be entertained only within a period of One (1) years from the date of publication or acceptance/ certification of a record/entry. However, discrepancies identified by the ABWR team shall be addressed regardless of passage of time. Applicants must note that, In accordance with the prevailing laws, there is no limitation in respect of criminal liability should it arise.

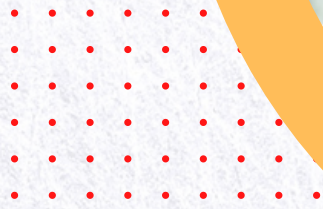
